### **RACHAKONDA CYBERCRIMES SLUETHS ARRESTED TWO NIGERIA NATIONALS FOR MAKING FRIENDS ON SOCIAL MEDIA PLATFORMS AND DUPING VICTIMS IN THE GUISE OF SENDING GIFT PARCELS.**

**CR.NO. 87/2023 OF CYBER CRIME PS, RACHAKONDA**

#### **DETAILS OF ARRESTED ACCUSED:**

- A1)** Omenonye Sylvester, S/o. Omenonye, Age: 23 years, Occ: Student, R/o. Tilak Nagar PS Limits, Delhi, N/o :Agbor, Asaba of Nigeria.
- A2)** Alimeke Endurance Chukkwuka, S/o: Alimeke, age: 23 yrs, Occ: Student, R/o. Tilak Nagar PS Limits, Delhi, N/o :Agbor, Asaba of Nigeria.

#### **SEIZED ARTICLES-**

- 1) Mobile phones – 06,
- 2) Wifi Router - 1
- 3) Passports – 02
- 4) Note books having hand written details of created fake social media profiles
- 5) Net Cash Rs.1,78,000/-

#### **DESCRIPTION OF CRIME:**

The accused persons A1) Omenonye Sylvester and A2) Alimeke Endurance Chukkwuka are hails from **NIGERIA**, both came to India separately on Student VISAs and residing at Delhi. In their fraudulent way, they impersonated as European citizen, made friendship with the victim M/s. Divya through the Instagram ID "Alex Williams" and duped her to collected ₹3,63,000/- from her on the name of sending gift parcel to her.

Basing on the technical evidence collected, the IO arrested the accused persons A1 & A2 at TilakNagar area of West Delhi on 15.08.2023 and sent to judicial custody. Further as per the preliminary technical analysis of the seized mobile phones, SIM cards, IMEI numbers of the accused, found that the accused persons A1 & A2 involved in Cr.No. 1361/2023 of KPHB PS, Cyberabad, 2) Cr.No. 1202/2023 of Cyber Crimes, Cyberabad, 3) Cr.No.1013/2023 of Cyber Crimes, Cyberabad, 4) Cr.No. 230/2023 of Chadarghat PS, Hyderabad, 5) Cr.No. 268/2023 of Cyber Crimes, Hyderabad, and other NCRP petitions reported across India.
