RACHAKONDA POLICE ARRESTED A HABITUAL INTER-STATE GANG INDULGING IN TYRES LOAD LORRY ROBBERY & THEFT AND RECOVERED (152) MRF TYRES, MARUTHI CIAZ CAR, ACTIVA BIKE, ONE 8 MM LIVE ROUND, ONE KNIFE (04) MOBILE PHONES AND, CASH RS: 20,000/- ALL RS. 44,72,760/- FROM THEIR POSSESSION

The sleuths of CCS LB Nagar team, IT Cell along with Pahadisharief Police of Rachakonda Police Commissionerate have made sincere efforts on 22.02.2022 **at morning hours** apprehended three habitual inter-state lorry tyres load theft offenders in the limits of Pahadisharief PS.

On: 19.02.2022 the main offender **A1.Jamsheed Khan @ Jammi** was arrested at **Delhi Airport** while escaping by flight and recovered a **8 MM live cartridge** who thrown it near godown in Katedan area.

BRIEF HISTORY OF ACCUSED:-The offender **A1 Jamsheed Khan @ Jammi.**, 2 years ago he came to Miryalaguda town for eking his livelihood and worked in puncture shop for 4 months. During that he met **A4 Afroz** and **A5 Basith** who used to come to his puncture shop for purchasing old and damaged tyres and also selling the new lorry tubes purchasing from **A6 Kamal** who is having a tyre shop in Begam bazaar, HYD, A1 used to meet A4 & A5 and was talking to them over mobile phones. As the A1 income was not sufficient he went to his native place. Later the A1 met **A2 Rahil & A3 Azad** at their village, hatched a plan to rob the lorry tyre load while travelling in loaded containers. As per their plan the offenders A1 to A3 robbed the lorry tyre loads twice i.e., on: 18.01.2022 (**220 Apollo lorry tyres**) & on: 18.02.2022 (**192 MRF lorry tyres**) and sold them to A6 Kamal Kabra at half price with the help of A4 & A5.

MODUS OPERANDI (M.O):-The offenders **A1 Jamsheed Khan @ Jammi and A2: Rahil Khan and A3. Azad** are belong to Mewat district, Haryana state. They used to recce at Lorry tyre factories or godowns, get in to the loaded containers as passengers, while travelling they threat the drivers with weapon, tie them with ropes, rob the tyres from loaded container lorry and sale them to known receivers at half rates.

BRIEF HISTORY OF CASE: On 15.02.2022 at about 23:00 hours the complainant loaded the 192 MRF tires at MRF limited, Trichy (Radial) Plant Narangal, Perambadur, Tamilnadu State. Which actually transported in the container BR No: NL01AD4374 to Haryana State with help of the complainant/Driver and along with one cleaner Sri. Soheli Khan to Deliver the said loaded tyres at MRF company, CP complex, (New Block), Bapu, Ashram Marg, ATII milestone, Sirsa Road, Hissar-125001, G.S.T 06AAACM4154 GIZR, Haryana State. At Tiruchi the offenders A1 Jamsheed Khan & A2 Rahil Khan asked lift for going to Haryana State as they belong to Haryana, hence they accepted and given lift. While they travelling from Tamilnadu to Haryana on the way on 17.02.2022 at about 03.00 hours the complainant driving handed over to his cleaner Soheli and slept, when they reached near Tipparthi of Nalgonda district one of them the offenders A1 & A2 threatened the Soheli with fire arm and stopped the container by road side and tied the hands & legs of the driver and cleaner with rope and blindfold them with cloth, moreover they beat the complainant and his cleaner with hands. They kept them in container and roamed his container here and there and finally they stopped container at Thukkuguda ORR and fled away. They released their hand and legs from rope with the help of the general public and noticed that whole 192 MRF tires were robbed by the offenders. Approximately the robbed property worth was Rs. 37,45,085/
