CHAITANYAPURI PS, SNEHAPURI COLONY DACOITY WITH FIRE ARMS AT MAHADEV JEWELLERS SHOP OCCURRED ON 1ST DECEMBER CASE. RACHAKONDA POLICE ARRESTED (06) INTER STATE OFFENDERS. RECOVERED - STOLEN JEWELLERY, FIRE ARMS & VEHICLES USED IN COMMISSION OF DACOITY. MASSIVE HUNT GOING ON FOR APPREHENSION OF (04) ABSCONDING INTERSTATE OFFENDERS.

CR. NO. 890/2022U/S 394, 397, 398, 212, 120 (B) IPC AND SEC 25 (1) (A), 27 (2) INDIAN ARMS ACT - 1859 OF CHAITANYAPURI PS, RACHAKONDA

Brief Facts:

On 01.12.2022 at about 1415 hours Sri. Raj Kumar Surana s/o Bhagvati Lalji Surana, a Businessman running Ganpathi Jewellers at Pot Market / Monda Market, Secunderabad along with his Assistant Sukha Ram @ Sukhdev Devasi started on his motorcycle, from his home carrying about 3 Kgs readymade gold ornaments in a bag, to sell in different jewelry shops in the city. As per their weekly schedule, like every Thursday they went to Navaratna jewelry shop at Boduppall, Navakar jewelry shop at Peerzadiguda Kaman, Raj Laxmi jewelry shop at Sushma, Bhavani jewelers, Sri Gajendra Jewelers in Vanasthalipuram and in these shops they sold about 135 gms gold and received Rs 2,63,600/- . They finally reached Mahadev Jewellers at Snehapuri Colony, Kothapet, Chaitanyapuri around 2000hrs and waited as shop owner Kalyan Chowdhary was busy with customers. When customers left, while they were displaying jewelry items to shop owner, two unknown persons entered into the shop and a third person closed the shutter from outside. One of the assailants threatened them with a pistol and asked them to handover the jewelry bag, when they resisted, he fired with pistol resulting in bullet wounds to Kalyan Chowdhary and Sukhdev. The assailants forcibly snatched their jewelry bag, opened the shutter and escaped on bikes.

Soon after the information from one responsible citizen, CP Rachakonda has alerted L B Nagar zone Law & Order police, SOT, Crime, IT cell teams. Addl CP Rachakonda G Sudhir Babu IPS, DCP L B Nagar Sunpreet Singh IPS, DCP Crime Sreebala with crime team, DCP SOT Muralidhar with SOT Teams, ACP LB Nagar Sreedhar Reddy, IT Cell Inspector Sreedhar Reddy with teams, Chaitanyapuri SHO Madhusudan, DI Venkanna & SHO LB Nagar Anji Reddy with CLUES teams had personally visited scene and started scientific investigation. 15 teams were deployed to collect all technical and direct/indirect eyewitness evidence. Breakthrough in this case came through one of the crime vehicle number partially captured by CCTV and developed by CCS Inspector Ravi Kumar with help of IT Cell. After relentless efforts as on today 7th December, (06) interstate offenders are arrested recovering from their possession jewellery stolen, firearms and crime vehicles used to commit

crime and escape post offence. Kingpin of this gang found to be one Mahender Chowdhary running jewellery shop at Gajwel N/o. Paali district Rajasthan who hired Haryana, Delhi bound professional offenders to commit this heinous crime.

The details of arrested accused persons:

- 1. A3: Banshi Ram @ Manish Dewasi S/o.** Anop ji, age: 23 years, Caste: OBC (Dewasi), Occ: Owner of Readymade Cloth shop Jai Bhavani collections, r/o: Reddy colony, Ramayampet village, & Mandal, Medak district. N/o: BirnatiyaKhurd village, Jaitaran, Paali district, Rajasthan. **(Pursuant to their conspiracy A2 to A5 executed the Dacoity)**
- 2. A6: Mohammed Firoz s/o** Jahangeer, age: 31 yrs, Caste: Muslim, Occ: Civil contractor, r/o: H.No. 7-50/6, Adarsha Nagar, Near Mahathi Auditorium, Gajwel, N/o. Bangla Venkatapur village, Gajwel, Siddipet District. **(Participated in the conspiracy, purchased Pulsar M/c on his name and aided the A1 to A5 in the commission of offence and also used his XUV car for travelling the accused after commission of offence)**
- 3. A7: Sumer Choudary s/o:** Mangilal, age: 26 yrs, Caste: Choudary (OBC), Occ: Gold Jewellery shop, r/o: Gouraram village, Vargal Mandal, Siddipet district. N/o: Jujhanda village, Jaitaran , Paali district, Rajasthan State. **(He is the brother-in-law of A1, participated in the conspiracy and aided the accused in concealing the stolen property and crime vehicle)**
- 4. A8: Gudiya Jaat w/o:** Jaat Mahender, age: 30 yrs, Caste: Jaat, Occ: Jewellery shop, r/o: Near Vegetable Market, Gajwel, Siddipet district. N/o: Jaitaran, Paali district, Rajasthan. **(She is the wife of accused A1, she too participated in the conspiracy and assisted A2 to A7 in concealing the case property)**
- 5. A9: Manish Vaishnav s/o** Rajesh Kumar, Age: 31yrs, Caste: OBC Vaishnav, Occ: Jewellery Shop and pawn broker, r/o: Kondapaka village & Mandal, near Bus stand, Siddipet district. N/o: Bornadi village, Sojat, Pali district, Rajasthan. **(Aided the accused and concealed the stolen gold ornaments, weapons and crime vehicle in his house)**
- 6. A10: RiteshVaishnav s/o** Dinesh Vaishnav, Age: 32 yrs, Caste: Vaishnav, (OBC), r/o: Gahnapur road, Nandini tent house, Palakurthy village & Mandal, Jangaon district. N/o: Chandawal Nagar village, Sojat City, Pali district, Rajasthan State. **(Previously worked in A1 Jewellery shop at Palakurthy, aided the accused and knowingly harboured the accused A2, A4 and A5)**

Accused to be arrested:-

- 1. A1: Mahender s/o** Udaram Choudhary, Age: 35 yrs, Occ: Jewellery Shop, r/o: Near Vegetable Market, Gajwel Mandal, Siddipet district. N/o: Pipiliya village, Paali district, Rajasthan State. **(He is the master mind of this offence & conspired about the dacoity along with A2 to, A8)**

2. **A2:** Sumit Dagar
3. **A4:** Manish
4. **A5:** Maniya

Investigation:

On 06.12.22 while making efforts, on receipt of credible information the Chaitanyapuri police apprehended A7 Sumer, A8 Gudiya and A6 Firoz at **Gajwel**, A3 Bhansi Ram @ Manish Dewasi at **Ramayampet**, A9 Mainsh Vaishnav at **Kondapaka** and A10 Ritesh Vaishnav at **Palakurthy** and drafted their confessions in the presence of mediators recovered the stolen gold ornaments, weapons, crime vehicles and other incriminating material pertaining to this case.

The investigation established that accused A1 was running jewellery business in the name & style as Jai Laxmi Jewellers at Gajwel. To earn quick and easy money, he hatched a plan to loot gold / cash from businessmen supplying to various jewelry shops and conspired with his wife Gudiya (A8), his brother-in-law Sumer Chowdhary (A7), acquaintances Md. Firoz (A6), Bhansi ram @ Manish Dewasi (A3) and secured the presence of Sumit Dagar (A2), Manish (A4) and Manya (A5) from Haryana/Rajasthan with deadly weapons to execute the armed dacoity with attempt to cause death. Accordingly, on 20.10.22 Haryana/Rajasthan offenders Sumit Dagar, Manya and Manish came to Gajwel and stayed in lodge in Gajwel for 7 days and conducted recce with suggestions from Bhansi Ram @ Manish (A3).

On 26.10.2022 in Gowraram PS limits of Siddipet the three accused Sumit Dagar, Manya and Manish threatened a Honda rider with weapon and took away the

Honda Activa with Helmet. (Which is subject the matter of Crime Number 183/22 U/s. 382 IPC of PS Gowraram). Later the accused shifted the vehicle to Rajasthan through Travel bus. **The next day the Accused left for Haryana.**

Sumit Dagar, Manya and Manish returned again to Ramayampet on 20th November 2022 and were received by A3 and stayed with him for 3 days. They stayed at Hyderabad, Gajwel and other areas looking with A1 and A3, for ideal persons and places to commit offences.

On 29th A2, A3, A4, A5, and A6 went to Gajwel Bajaj Showroom to purchase a Fast bike for escaping after commission of offence and A6 purchased a Pulsar in his name financed by A1.

On the day of offence i.e., 01.12.2022 around 1030 hours Bansiram and Manya started from Ramayampet on White Honda Activa belonging to A3 and reached Pot market around 1230 pm. Meanwhile Sumit Dagar and Manish started from Ramayampet around 1130 hrs on pulsar and waited near JBS. A3 and A5 started watching movement of Raj Kumar Surana. At about 1400 hours Raj Kumar started on his Honda from his jewelry shop along with his Shop Assistant Sukha Ram, with about 3 Kgs readymade Gold ornaments in a shoulder bag. As per their weekly schedule, went to Navaratna jewelry shop at Boduppall, Navakar jewelry shop at Peerzadiguda Kaman, Raj Laxmi jewelry shop at Sushma, Vanasthalipuram, Bhavani jewelers, Sri Gajendra Jewelers in NGOs colony, Vanasthalipuram, and in these shops, they sold about 135 gms gold and received Rs 2, 63, 600/-. Finally they reached Mahadev Jewellers at Snehapuri Colony, Kothapet, Chaitanyapuri around 2000 hrs, but had to wait as shop owner Kalyan Chowdhary was busy with customers. When customers left, while they were displaying jewelry items to shop owner, Sumit Dagar (A2) and Manish (A4) entered into the shop, while Manya (A5) closed the shutter from outside and A3 waited nearby with his Honda Activa ready. A2 threatened the complainant, his assistant, shop owner with a pistol and asked them to handover the jewelry bag, when they resisted, he fired with the pistol resulting in bullet wounds to Kalyan Chowdhary and Sukhdev. A2 forcibly snatched the jewelry bag, while A4 and A5 opened the shutter and ranout. A2 and A3 escaped with the stolen jewellery bag on the Honda Activa. A4 and A5 escaped on the pulsar and reached Uppal area and left the Pulsar in Habsiguda area.

Meanwhile Firoz (A6) drove Mahender (A1) in his XUV from Gajwel were waiting at a Restaurant in Uppal, on receiving a call from the offenders they rushed and picked up Sumit Dagar (A2) in XUV. Whereas A3 Bansi Ram @ Manish went to Ramayampet on his Honda Activa. While Mahender (A1) and Sumit (A2) with stolen jewellery bag went to Palakurthy, Firoz (A6) got down at GhatkesarBusstop and picked up Manish (A4) and Manya (A5) and brought them to Jangaon by bus. By

then Mahender reached Jangaon in the XUV after dropping Sumit Dagar at Palakurthy and drove them all to Palakurthy to the house of Ritesh Vaishnav (A 10) and later from there to Gajwel.

On the same night A7 picked up the crime vehicle (pulsar) left by A4 and A5 at Habsiguda and drove it to Gajwel. From there he went on the bike to Kondapaka with his sister (A8) and hid the pulsar and bag containing firearms in the bedroom of Manish Vaishnav (A9) and returned to Gajwel and Gouraram. Later in the evening A7 accompanied Mahender to Palkurthy in Ertiga (belonging to Mohan Dewasi) and picked up A2, A4 and A5 came to Gajwel. En-route, Mahender handed over 4 lakhs to A2 and collected the bag containing with stolen gold ornaments and a pistol from him (A2). Mahender handed over the bag to A7 and on his instructions Gudiya and Sumer took some pouches of gold ornaments, one pistol and hid it in the house of Mahender (A1). Later A7 and A8 (Gudiya) went to Toopran road on Mahender's HF Deluxe Bike, and Gudiya boarded ERTIGA driven by Mahender in which the three offenders were present. A7 came back to Mahender's house and took the bag with two boxes of stolen gold jewelry, went to Kondapaka on his HF Deluxe motor cycle and hid the bag in the same room where they hid the Pulsar and weapons.

On 2nd December 2022 around 1030hrs A1, A2, A4, A5, A8 started in Ertiga car bearing no. TS-27-E-2903 and travelled towards Maharashtra by leaving the weapons and stolen gold ornaments to keep themselves safe from police checking's. Around 0030 hrs A1 dropped A8 (Gudiya) at Nirmal from there she boarded a bus to Hyderabad and then returned to Gajwel.

Sri Mahesh M Bhagwat, IPS., Commissioner of Police, Rachakonda formed a Special Teams comprising of CCS, SOT, IT Cell and L & O police for investigation and detection of case. (04) Special Teams were constituted and deployed to **Nagpur, Haryana, Rajasthan, Delhi** for arresting the absconding **inter-state criminals**. Further he closely monitored the day to day progress and guided the Teams. Sri G Sudheer Babu, IPS., Addl. CP Rachakonda, Sri Sunpreet Singh, DCP, L.B. Nagar Zone, Ms. Sreebala, i/c DCP Crimes with Addl. DCP Crimes M Srinivasulu & CCS Inspectors T. Ravi Kumar, Saidulu, Manmohan, Ashok, Sri K. Muralidhar, DCP, SOT with SOT ACP Venkanna Naik, SOT Inspectors A. Sudhakar, A. Ramulu & G. Naveen Kumar carried out the instructions of the CP Rachakonda , detected the case and recovered the entire stolen property, crime weapons and other evidence in a record period. All are suitably rewarded. CP Rachakonda has advised jewellery shop owners to install sensors, alarms, CCTV cameras inside and outside of shop. Avoid routine movement of transportation of jewellery and always maintain elements of surprise.
