

## PRESS NOTE

**INTERNATIONAL NARCOTICS PEDDLING RACKET BUSTED. TWO DRUG PEDDLERS NABBED BY SOT, MALKAJGIRI ZONE TEAM ALONG WITH NACHARAM POLICE, RACHAKONDA AND SEIZED ABOUT (500) GRAMS OF PSEUDOEPHEDRINE (A NARCOTIC CONTROL SUBSTANCE) & SMUGGLED GOLD (80) GRAMS ALL W/RS. 55 LAKHS IN INTERNATIONAL MARKET.**

On credible information, the sleuths of Special Operations Team (SOT), Malkajgiri Zone team along with Nacharam police busted an international narcotic peddling racket and apprehended the accused viz., 1) Shaikh Fareed Mohammad Ali and 2) Faizan Arun Mujahed @ Faisal who are involved in clandestine supply of pseudoephedrine (a narcotic control substance) being parcelled through an international courier agency from Hyderabad to Australia and New Zealand.

### **The details of the accused persons:-**

1	: <b>Shaikh Fareed Mohammad Ali</b> S/o. Mohammad Ali, age 30 yrs, Occ: Business, R/o. Near Ram Mandirgalli, 54/ap, 103 Lohiya Nagar Ganjpeth, Pune City, Maharashtra. <b>(A3)</b>
2	: <b>Faizan Arun Mujahed @ Faisal</b> S/o. Arun, age: 28 yrs, Occ: Broadband Technician, R/o. H.No: 28B, Guljar Housing Society, Gunjpet, Mominpura, Pune, Maharashtra. <b>(A4)</b>

### **Seized Property:-**

1. Pseudoephedrine – approximately 500 grams.
2. Net Cash Rs. 2500
3. Gold – (80) Grams approximately.
4. Passport - (01)
5. Mobile phones- (02) All property about W/Rs. 55 Lakhs.

In the above case the SOT, Rachakonda and Nacharam Police have arrested A1) Mohammad Kasim and A2) Rasuldeen and send them to judicial custody on 11.12.2022, along with the drug weighing about 8.5 kilograms. In further investigation on reliable information, in the early hours the SOT, Malkajgiri team along with Nacharam Police apprehended A3) Sheik Fareed and A4) Faizan @ Faizal who came to Hyderabad with a plan to send the remaining drug to the address provided by Raheem. Meanwhile they were caught by police.

On searching the bag carried by Fareed a plastic cover was found containing white powder like substances (pseudoephedrine), which weighing about 500 grams and gold weighing about 80 grams. On examination they confessed that they arrived in Hyderabad to send the drug parcel to Australia and sell the gold that was smuggled from Malaysia to the localities of Pune and Hyderabad.

**About Sheik Fareed Mohammad Ali (A3):** Fareed hails from Pune. He visits Chennai regularly to visit his elder sister and brings electronic goods from Malaysia along with his brother in-law namely Basheer Ahmed, while he was doing foreign goods business, he got introduced along with his friend Faizan @ Faizal (A4) to Rasuldeen (A2) R/o. Chennai. Rasuldeen (A2) introduced both of them into drug business. All the accused travelled to Hyderabad, Chennai and Pune several times and Fareed and Faizal sent drugs to Australia and New Zealand through international Courier Services.

**About Faizan Arun Muzaheed @ Faizal (A4):** He also hails from Pune, a close friend of Fareed and knew about his foreign goods business. He helps Fareed in transporting drugs at international parcel companies for easy money.
