INTERSTATE GANJA SMUGGLING RACKET BUSTED BY SOT, MALKAJGIRI ZONE & MEDIPALLY POLICE – (02) HELD - SEIZED 510 KGS OF GANJA, OTHER INCRIMINTATING MATERIAL ALL WORTH ABOUT RS. 1,28,58,000/-. (One Crore twenty eight Lakhs fifty eight thousand rupees approximately)

On 08.12.2023 credible information, the sleuths of Special Operations Team, Malkajgiri Zone along with Medipally police apprehended two persons who were indulging in transportation of Contraband Ganja from Kalimela of Odisha State to Hissar, Haryana State to gain illegal money and seized 510Kg's of Dry Ganja, Piaggio Goods Carrier Vehicle and 02 Mobile Phones all worthRs.**1,28,58,000/-**. (One Crore twenty eight Lakhs fifty eight thousand rupees approximately)

BRIEF FACTS:-

The receiver is having good contacts with Ganja suppliers of Odisha State and hatched a plan of transporting Ganja from Odisha to Hissar of Haryana for gaining illegal money.

As per his plan he went to Odisha, met with a dry Ganja supplier from Kalimela, Odisha, made a deal of supplying the Ganja and paid the amount. Later he went back to Hissar, met his friend Parveen Kumar and his relative Manohor, explained his plan of transportation of Ganja and asked for their support. Due to

meager earnings, they have accepted his offer. Further he provided one Piaggio Goods Carrier Vehicle bearing no MH 49 AT 7154 to them, which is having a secret partition in it to hide the Ganja during transportation. As per their plan, Parveen Kumar & Manohor went to Kalimela, Odisha in the provided vehicle, collected the Ganja, loaded it in the secret cabin of the vehicle and started to Hissar, Haryana.

When they reached Medipally, the SOT Malkajgiri team along with Medipally Police were checking vehicles on suspicion, they checked their vehicle thoroughly and found dry Ganja in the secret cabin.

The above arrests were made under the direct supervision of Sri. D S Chauhan, IPS., Commissioner of Police, Rachakonda, and under the guidance of Smt. D. Janaki, IPS., DCP, Malkajgiri Zone, Sri. R.
