Facts Of the Case: -

The accused A-1 to A-6 have indulged in illegal transportation of Ganja and they transport ganja regularly from agency area Rampachodavaram, Rajahmundry of A.P state to Beed District of Maharastra state. The accused A-1 used to

purchase ganja from A-5 at Rampachodavaram agency area for kg an amount of Rs. 2000/- and the same would sell in Maharastra state per kg an amount of Rs.10,000/- to the accused A-2 to A-4. Later the accused A-2 to A-4 same ganja was selling to their prospective customers per kg an amount of Rs.20,000/- and making huge profits by doing this illegal business. As usual today i.e on 31.05.2023 the accused A-1 & A-6 went to Rampachodavaram and met with A-5 Dhanu and loaded 450 Kgs of Ganja in their Innova Car Br.No. MH 24 V 5200 and the same was transporting to Maharastra state, on the way when they reached at ORR, Peddamberpet on 01.06.2023 at around 12:00 hours, on specific information Police Hayathnagar conducted vehicle checking and apprehended them and taken them into custody and found total (25) bags Ganja weight about 450 Kgs, one Innova Car Br.No. MH 24 V 5200, two mobile phones, one Iron rod, net cash an amount of Rs. 20,000/- from their possession all worth Rs.1.2 Crores.
