INTERSTATE GANJA TRANSPORTING RACKET BUSTED BY SOT, LB NAGAR ZONE & ABDULLAPURMET POLICE, RACHAKONDA – HELD (04) FOR TRANSPORTING GANJA FROM ODISHA STATE TO RAJASTHAN VIA HYDERABAD – SEIZED (200) KGs OF GANJA ALL W/RS. 45 LAKHS.

On 02.09.2023 early hours, acting on a tip off the sleuths of SOT, LB Nagar Zone Team along with Abdullapurmet police busted interstate Ganja peddling racket and seized (200) KGs of Ganja from their possession.

Brief Facts:-

As part of proactive action against the drug peddlers the SOT, LB Nagar Zone team along with Abdullapurmet police apprehended an interstate Ganja transporting syndicate.

The A1 to A4 are having acquittance with each other, they wanted to earn easy money by transporting Ganja from Odisha State and sell it at Rajasthan State and make huge money within no time. The A1 who is involved in the similar offence has assured for arranging the Ganja source and A2 to invest the money for the contraband and A3 & A4 to support them in the transportation of contraband.

Accordingly, the A1 to A4 came to AOB, in their Hyundai i20 car, purchased 200 KGs of Ganja, concealed the same in the car and were proceeding to Rajasthan, enroute police apprehended them near ORR and seized the contraband from their possession. The accused used to sell the contraband in local market @ Rs.20,000/- and more basing on the demand and earning illegally.

To mislead the police the accused used different font size number plate and also taken the new route i.e., Sileru, Chintur, Badrachalam, Khammam, Suryapet, ORR, Medchal, Kamareddy, Adilabad, Nagpur, Bhopal, Kota, Ajmer of Rajasthan State.

The arrested accused are being produced before the Honorable Court for judicial remand.

The above arrests were made under the direct supervision of Shri D S Chauhan, IPS., Commissioner of Police, Rachakonda Police Commissionerate by Shri K. Muralidhar, DCP, SOT, LB Nagar-Maheshwaram Zones, and his team along with Abdullapurmet police.
