**APPREHENDED THREE NOTORIOUS NIGHT HOUSE BURGULARY CUM SNATCHING OFFENDERS (A-1 DASARI MURALI @ BALU @ MURALI KRISHNA, A-2 KUTHATI PARAMESH AND A-3 THOTA SARAIAH & RECOVERED 44.5 TULAS OF GOLD ORNAMENTS, 1.2 KG SILVER ORNAMENTS, Rs. 1,59,000 NET CASH AND ONE TVS XL VEHICLE, TWO CELL PHONES ALL W/RS. 25,93,820/-**

The sleuths of CCS Bhongir team have made sincere efforts with technical support of IT Cell unit Rachakonda and with the help of Bhongir Rural PS, today i.e. 06.06.2022 at 10.00 hours apprehended three offenders under suspicious circumstances at Raigir junction while conducting the vehicle checking towards Mothkur road. On questioning they revealed their detailed criminal history as mentioned below and confessed the following offences.

### **Brief History of Accused Persons:**

**A1 Sri. Dasari Murali @ Balu @ Krishna** is an old habitual offender. He started committing offences at the age of 22 years. Previously he was arrested in various district of Telangana. Two times he was arrested by Rachakonda Police. Once PD Act also initiated against him by Nellikiduru Police of Mahabubabad district. He was involved in a sensational case of 84 tulas gold theft in newly married house in Midjil PS limits, Mahaboob Nagar subsequently arrested by them and initiated PD Act second time against him. Later he was released on 24th August, 2021 and started offences with his associates, viz. Dasari. Narsaiah (his father), Angadi Suresh, Angadi Jampaiah, Kuthati Paramesh, Bijili. Mallaiah. Dasari Narsaiah and Angadi Jampaiah are in Nalgonda jail who were apprehended by LB Nagar CCS recently. On interrogation the A-1 confessed 17 offences committed in various Police stations limits in different heads like, Bike theft, HB Night, and snatching from the sleeping women. **Previously he was involved in 37 cases in various districts of Telangana. 12 NBWs are pending against A1 in various Police Stations.**

**A-2 Kuthati Paramesh** is also an old habitual offender. He has started committing property offences at the age of 19 years. He was habituated to bad habits where his earnings were not enough. He along with A1 Dasari Murali and other associates are committing offences continuously. Lastly he was released from Warangal jail in 21-01-2021. A-2 confessed 4 offences from various Police stations in HB Night and automobile offences. **Previously he was involved in 52 cases in various districts of Telangana. 2 NBWs are pending against A-2 in various Police stations.**

**A-3 Thota Saraiah has been involved in only one case in Nirmal district. He has no past criminal history.**

**MODUS OPERANDI (MO):** – The offenders A1 and A2 used to mainly target the isolated houses, road side houses at out skirts of the villages in rural areas. After consuming liquor they used to commit offences by choosing the locked houses. They also commit offences even when family members are in the house when they do not close main doors or kitchen doors. Especially they loot many houses in summer season and commit snatchings on sleeping women. They commit offence in number of houses in same village at same night with his group members. The A1 used to break the door lock with iron rod and enter in to the house, A-2, used to lurk outside the house.

Under the leadership of **Sri. Mahesh M Bhagwat IPS, Commissioner of Police** and **Sri. G Sudheer Babu IPS, Addl. Commissioner of Police**, with the guidance of **Sri. P. Yadagiri IPS, DCP Crimes**, and **Sri. K. Narayana Reddy IPS, DCP Bhongir Zone**, under supervision of **Smt.Laxmi Addl.DCP crimes** and **Sri. G.Ravi, ACP Crimes** the following team of CCS Bhongir made a key role in apprehension of the offenders i.e. **Inspector Sri. K. Shiva Shankar**, SIs, Y.B Ravinder, D.Vijay, D.Harish Reddy and HCs Srinivasan, Prakash, PCs Chandra shekhar, Kishore, Shyamaiah, Narender (CCS Bhongir),Mahesh, Brahmam (MKG CCS), Mohan and Manohar (IT cell). Inspector Bhongir Rural and his team assisted CCS Bhongir team.
