INTERSTATE DRUG PEDDLING RACKET BUSTED BY SOT MALKAJGIRI TEAM ALONG WITH GHATKESAR POLICE FOR TRANSPORTING HASHISH OIL WORTH RS. 1.15 CRORE

In a Joint operation, the sleuths of the Special Operations Team (SOT), Malkajgiri along with the Ghatkesar Police, have successfully apprehended one inter-state drug peddler involved in the transportation of Hashish oil.

Brief Facts:-

The CCL Boy is a native of Andhra Pradesh state and he has four brothers and two sisters, his Parents are farmers, the CCL Boy discontinued his studies from 6th class who was studying in APR School of G. Madugul, of A.P state as he was not interested in studies, since then he is helping his parents in agriculture and sometimes he is attending labour work also, during the course of time he got into contact with one Debendra Jhodia @ Srinu of Chitrakonda of Odisha State who transports Ganja to Hyderabad, with his influence both hatched a plan to supply Ganja and Hashish oil to Hyderabad and surrounding areas in order to gain money easily.

As per their pre-plan the Debendra Jhodia @ Srinu procured **5.1 KGs** of Hashish oil and wanted to transport to Hyderabad through the CCL boy, as Police would not suspect the CCL as he is a Juvenile.. Accordingly on 15.10.2025 the CCL Boy collected Hashish Oil from Debendra Jhodia @ Srinu and proceeded to Hyderabad by train and he got down at Ghatkesar railway station today morning i.e., 17.10.2025 and while he was moving suspiciously in the Ghatkesar railway station road he was stopped and checked by SOT, Malkajgiri Zone team along with Ghatkesar Police and found (5.1) KGs of Hashish Oil which was packed in two polythene covers and placed in one backpack which is all worth of Rs. 1.15 Crores

(as per market value) as such Police has seized Hashish oil and one Mobile Phone from his possession. The main accused (Debendra Jhodia @ Srinu) who procured the Hashish oil is absconding. Efforts are in progress to apprehend the absconding accused.

It is learnt that approximately 40 to 50 KG of Ganja is used in preparing 1 KG of Hashish Oil.

Appeal to the Public: The Police Rachakonda hereby appeals to all the citizens/Society that not to involve in any illegal activities and feel the responsibility and be a part in curbing the menace of Drugs and make a Drug free society.

Effects of Hashish Oil on health include:

- > Sensory distortions.
- > Nausea, vomiting, and stomach cramps.
- > Significant loss of motor coordination.
- > Changes in respiration.
- Increased heartbeat and blood pressure and the risk of <u>cardiovascular</u> <u>issues</u> (e.g. heart attack).
- > Extreme sleepiness.
- > Increased appetite and weight gain.
- > The increased potential to be involved in accidents due to the loss of coordination and poor decision-making.
- > Depression.
- > Anxiety, panic attacks, confusion, and a sense of a loss of control.
- > An inability to make sound decisions.
- Continuous usage of Hashish Oil effects CNS and might lead to Brain stroke.

Caution: It is also instructed to all the public at large and be aware of that procuring, selling, transportation and consumption of Narcotics drugs and Psychotropic substances is a Grave crime and punishable for imprisonment upto 10 years and also death penalty, according to Section 31A of the NDPS Act.
